

## **SUMMARY ANNUAL REPORT**

### **For Iron Workers Local Union No. 404 Annuity Fund**

This is a summary of the annual report for Iron Workers Local Union No. 404 Annuity Fund, EIN 25-1754959, Plan No. 002, for period May 1, 2021 through April 30, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$5,988,525. These expenses included \$202,741 in administrative expenses, \$5,771,206 in benefits paid to participants and beneficiaries, and \$14,578 in other expenses. A total of 1,946 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$68,051,889 as of April 30, 2022, compared to \$74,675,145 as of May 1, 2021. During the plan year the plan experienced a decrease in its net assets of \$6,623,256. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$634,731), including employer contributions of \$3,457,936, earnings from investments of (\$4,110,222), and other income of \$17,555.

The plan has a contract with Empower/Great-West Life & Annuity Insurance Company which allocates funds toward General Account.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Iron Workers Local 404, 1807 Spring Garden Street, Philadelphia, PA 19130) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
